COMMENCING AT THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 14; THENCE SOUTH 88°56'12" WEST, A DISTANCE OF 523.90 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE SOUTH 88°56'12" WEST, A DISTANCE OF 350.35 FEET TO A POINT LYING ON THE EAST LINE OF LOT 1 OF TONY PARDEU MINOR PLAT, AS RECORDED IN BOOK "C", PAGE 102, PUBLIC RECORDS OF CRAIGHEAD COUNTY, AT JONESBORO, ARKANSAS; THENCE NORTH 01°51'15" EAST, ALONG SAID EAST LINE, A DISTANCE OF 500.32 FEET TO A POINT LYING ON THE SOUTHERN RIGHT-OF-WAY LINE OF SOUTHERN PACIFIC RAILROAD; THENCE NORTH 83°32'28" EAST, ALONG SAID RIGHT-OF-WAY LINE, A DISTANCE OF 353.62 FEET, SAID POINT BEING THE NORTHWEST CORNER OF WEST WASHINGTON BUSINESS COMPLEX PHASE I AND PHASE II, AS RECORDED IN BOOK "C", PAGE 102, PUBLIC RECORDS OF CRAIGHEAD COUNTY, AT JONESBORO, ARKANSAS; THENCE SOUTH 01°51'18" WEST, ALONG THE WEST LINE OF SAID WEST WASHINGTON BUSINESS COMPLEX PHASE I AND PHASE II, A DISTANCE OF 533.62 FEET TO THE POINT OF BEGINNING.
