Good Evening to all of you,

Last night at the Public Works meeting, I certainly wasn't prepared to ask any questions concerning RES-20-139 since it was walked on to the agenda.

I would like to state again, to be fair and to be transparent to the citizens that you all represent, unless the Resolution is an emergency, there shouldn't be anymore walk on's. All the information needs to be followed by the rules and procedures that the City has adopted to get items on each Committee's agenda.

Today, I did some of my homework. I went to go look at the Maintenance Department Building located at 215 E. Allen Avenue. I then looked at the vacant lot which is located right behind the Maintenance Building- that being 202 E. Gordon Street.

I then went to go look at the building that is proposed to be purchased from Tim Thrasher and Tim Allison for the purchase price of \$550,000.00 located at 907 Congress Circle. The building has a Halsey/Thrasher/Harpole real estate sign in the front.

I have four(4) questions/ideas for you at this time:

- 1. Why not build a new shop on Dan Avenue with the \$350.000.00. This is where the other City's shops are located. Everything would be centralized.
- If I remember years ago when the City purchased the current administration building, Mayor Perrin wanted to have ALL or most of the departments under one roof. That was one of the reasons for purchasing it. The same would hold true in this situation- All the City's shops would be under one roof!
- 2. Why not build a new shop or update where the old shop is located now? The gentleman last night from the Maintenance Department mentioned that they would have to have \$15,000.00 for a new phone system. Guess what? There's \$350,000.00 that has been given to the Maintenance Department, they will still have \$335,000.00 to use!! And they won't have to ask Steve Purtee for anymore money!
- 3. If you centralized all the City's shops out on Dan Avenue, why not consider the old shop for a homeless shelter? I reached out to Regina today and did not hear back yet. I wanted to talk to her about available grants. If there is a grant(s) that we could get or even if the City partnered up with HUD to finally get this project finally started- how great would that be!

4. Once again, centralize all the City's shops out on Dan Avenue, why not then sell the old shop and the property on Gordon Street at a competitive bid?

These ideas are a WIN-WIN for the City and maybe the homeless citizens. It might not be for Tim Thrasher and Tim Allison.

#### Patti:

The purchase of the property on Congress would be considerably less than building a new building on city property. A new building to meet Maintenance's needs would be over \$900,000. The Congress property is in a good location for Maintenance, meets all their needs, and is available now with no significant modifications. There is no other building on the market that has these features and advantages. There has been discussion and negotiations on the purchase of the Congress property and sale of Maintenance's existing building for quite some time, and we were able to negotiate on a net price well under what was originally discussed. Bidding out the existing Maintenance building would most likely not result in a higher price, and would have delayed the transaction such that we may have lost the opportunity to buy the Congress property.

You may recall that the \$350,000 net cost was specified for "net property swap for upgraded maintenance facility" in the request for new capital spending in Resolution 20-115 which was discussed by the Finance Committee on 8/11/20 and the Council on 8/18/20. Also, the specific transaction was reviewed and approved by the Building Maintenance Committee on 8/26. The primary reason the Mayor asked for a walk-on resolution for the transaction at the 9/1 Public Works Committee is that we didn't want to lose the opportunity to get the Congress building, and to allow Maintenance time to transition/move. In response to your question, the city had the existing facility appraised, and the owners of the Congress property had it appraised. Also, regarding your 9/7 email, I can see no reason to consider a conflict of interest between a candidate for City Clerk (who currently has no official capacity with the city) and one of the owners of the Congress building.

Just by coincidence, the next Public Works Committee meeting and City Council meeting is on 9/15/2020.


So my two questions to whoever would like to answer are:
