Patti Lack 4108, Forrest Hill Road, Jonesboro. My question to you all is, why is the city paying \$67,000.00 to the Cooper-Mixon Architect group to put up a metal building out on the Lacy Drive property? Apparently that was going to be adequate enough for the Facility Maintenance Department when looking at the facility on Congress Drive last year. Again, can you explain why we are spending this money to an Architect to design this building? Chairman John Street asked City Engineer Craig Light to come forward to help answer Ms. Lack's questions.

City Engineer Director Craig Light said that he did not know if he could answer the question of why the city did not purchase the building out on Congress Cove. Mr. Light went on to explain the he did know that the decision was made in the 2021 budget to fund the construction of a new Building Maintenance Facility Shop out at the Lacy Drive property. So, we've gone through the selection process to hire an Architect to design that facility. I think the budget for the project is at \$900,000. Chairman John Street said to Mr. Light, I think her question was, why do we have to hire an Architect to build a Metal Building? Mr. Light explained that an Architect is required for any type of Commercial Construction that is over \$100,000. Ms. Lack asked what the plans were for the old Building Maintenance Facility once that department moves out of it. Mayor Harold Copenhaver explained that he has been in discussion with Building Maintenance Director Ronnie Shaver regarding the next phase for the old maintenance facility. What we will do as a community or city is sell the property at that point. Ms. Lack said "okay". I know it had been brought up in conversation last year to see if it might could be used for the homeless shelter.

WHEREAS, the City of Jonesboro has desires to enter into a contract for the Jonesboro Shooting Sports Complex Phase IIC - Range Building construction;

WHEREAS, the low bidder and the firm selected for the Jonesboro Shooting Sports Complex Phase IIC - Range Building project is Olympus Construction; and,

WHEREAS, funding for the execution of the contract shall come from the Capital Improvement budget and compensation shall be paid in accordance with the agreement.

NOW, THEREFORE BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS;

Section 1: That the City of Jonesboro shall accept the low bid and enter into a contract with Olympus Construction for the Jonesboro Shooting Sports Complex Phase IIC - Range Building construction.

Section 2. That funding for the execution of the contract shall come from the Capital Improvement budget and compensation shall be paid in accordance with the agreement.

Section 3. The Mayor and the City Clerk are hereby authorized by the City Council for the City of Jonesboro to execute all documents necessary to effectuate this agreement.
