WHEREAS, the City of Jonesboro passed the 2017 Budget in Ordinance 16:085, which will need to be amended in order to effectuate said increase in the General Fund Budget for the addition of a Social Media Coordinator, the budgeted amount for the Mayor's budget will need to be increased a total of \$13,451; \$7,389 for line item Salaries - Mayor's Office 01-131-0201-00; \$230 for line item Holiday Pay 01-131-0202-00; \$325 for line item Medicare Contributions 01-131-0284-00; \$1,388 for line item Payroll Taxes 01-131-0206-00; \$1,119 for line item Retirement 01-131-0295-00; and \$3,000 for line item Group Insurance 01-131-0203-00.

WHEREAS, \$15,000 of the line item Part-Time Salaries 01-131-0210-00 will be moved to Salaries - Mayor's Office 01-131-001-00.



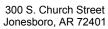


