Dear Sir/Madam:

The Federal Highway Beautification Act of 1965 requires the Arkansas State Highway and Transportation Department to enforce billboard sign control laws adjacent to the referenced highway. If we do not do this, the State of Arkansas can lose up to 10% of its annual share of Federal highway construction money, amounting to millions of dollars each year.

Unfortunately, your permit applications pertaining to the referenced billboard signs cannot be approved for the following reason(s):

- The sign site is zoned R-1 Residential. Billboard permits can only be issued in Commercial or Industrial zones.
- Since the sign location cannot be approved for a permit, please remove the signs, including the support pole, within 60 days.

Your application fee refund will be returned when received from the State Auditor.

In accordance with the Arkansas Administrative Procedure Act, you or the landowner may have a hearing in Little Rock regarding this decision by sending a written request to me within thirty (30) days.
