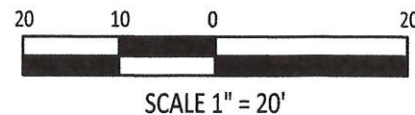


**EXISTING R-3 ZONING

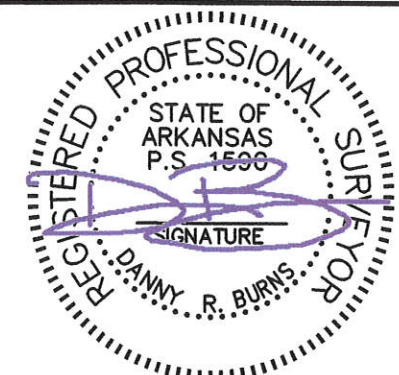
