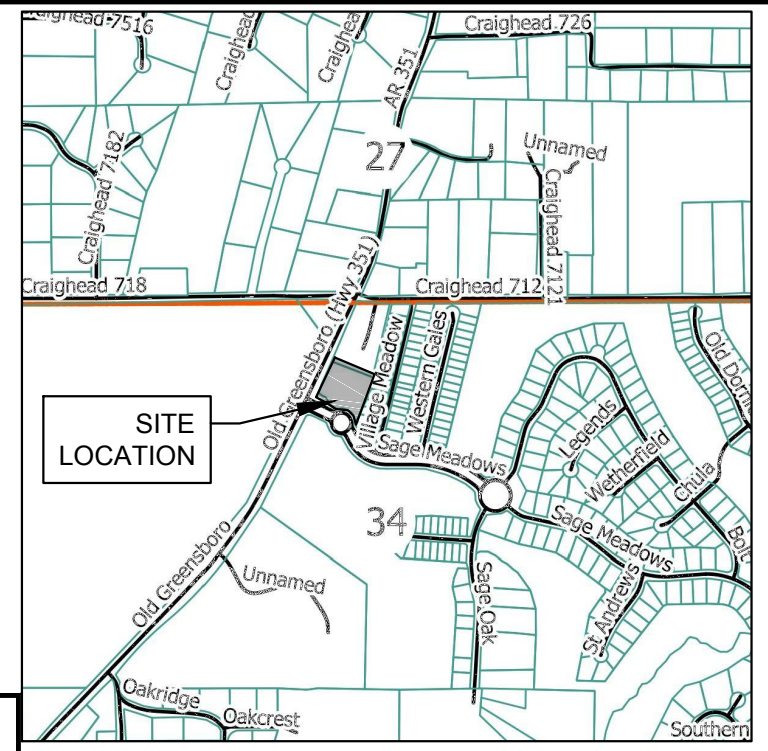


EXISTING ZONING: C-3

DESCRIPTION:
A PART OF THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER OF SECTION 34, TOWNSHIP 15 NORTH, RANGE 4 EAST, CRAIGHEAD COUNTY, ARKANSAS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF SAID SECTION 34; THENCE SOUTH 00°18'47" EAST 46.48 FEET; THENCE SOUTH 89°18'22" WEST 39.29 FEET; THENCE SOUTH 13°37'23" WEST 522.56 FEET TO THE POINT OF BEGINNING;

THENCE SOUTH 13°37'23" WEST 124.38 FEET; THENCE SOUTH 23°28'50" WEST 217.97 FEET TO A POINT ON THE NORTH RIGHT OF WAY OF SAGE MEADOWS BOULEVARD; THENCE NORTHWESTERLY ALONG A CURVE HAVING AN ARC LENGTH OF 29.77 FEET, A RADIUS OF 50.00 FEET, A CHORD LENGTH OF 29.34 FEET WITH A BEARING OF NORTH 16°05'09" WEST TO A POINT; THENCE ALONG A CURVE HAVING AN ARC LENGTH OF 160.52 FEET, A RADIUS OF 94.96 FEET, A CHORD LENGTH OF 142.08 FEET WITH A BEARING OF NORTH 47°26'52" WEST TO A POINT; THENCE ALONG A CURVE HAVING AN ARC LENGTH OF 30.68 FEET, A RADIUS OF 50.00 FEET, A CHORD LENGTH OF 30.20 FEET WITH A BEARING OF NORTH 78°16'05" WEST TO A POINT; THENCE ALONG A CURVE HAVING AN ARC LENGTH OF 23.02 FEET, A RADIUS OF 401.86 FEET, A CHORD LENGTH OF 23.02 FEET WITH A BEARING OF NORTH 62°19'50" WEST TO A POINT; THENCE NORTH 63°45'42" WEST 100.69 FEET; THENCE ALONG A CURVE HAVING AN ARC LENGTH OF 39.06 FEET, A RADIUS OF 25.00 FEET, A CHORD LENGTH OF 35.21 FEET WITH A BEARING OF NORTH 18°59'22" WEST; THENCE NORTH 25°46'58" EAST 190.50 FEET; THENCE SOUTH 76°50'15" EAST TO THE POINT OF BEGINNING PROPER.

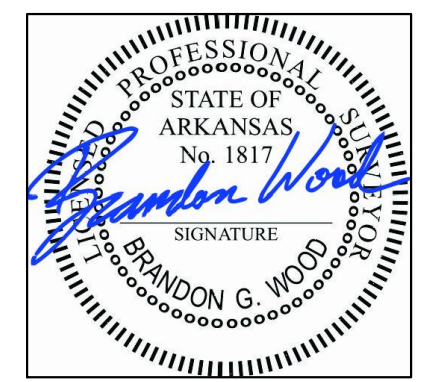
