Chairman Street noted this is based on the International Commercial and Residential Building Codes. City Engineer Craig Light explained this code is existing in the Fire Prevention Code that has historically not been enforced by the city. It will require residential contractors to submit a little more information on their site plans to show where the property drains and what the elevations are. It will also require six inches of fall within the first ten feet of the structure and that it be twelve inches above the point where it drains, plus 2%. Those things will have to be checked before a building permit is issued. He reiterated all of that is part of existing code; it just hasn't been enforced. They are having issues where contractors and builders are setting their structures on the ground and creating their own water problems.

Chairman Street stated it's like building something in a bowl, so this will stop that. Mr. Light further explained they didn't want to be arbitrary and just start enforcing something; rather, they wanted to bring something to Council and get their endorsement to start enforcing it.

Councilman Moore asked if this was part of the Fire Prevention Code. Mr. Light answered yes, the Fire Prevention Code has the residential building code.
