FOR THE CROWLEY'S RIDGE PARKWAY: CRAIGHEAD FOREST PARK TRAIL - PHASE 2 (AHTD JOB NO. 100856) (2016:27) WHEREAS, the City of Jonesboro has desires to accept the low bid and enter into a contract for the Crowley's Ridge Parkway: Craighead Forest Park Trail - Phase 2 (AHTD Job No. 100856); and

WHEREAS, the low bidder and the firm selected for the Crowley's Ridge Parkway: Craighead Forest Park Trail - Phase 2 (AHTD Job No. 100856) is Sugg Construction, Inc.; and

WHEREAS, funding for the execution of the contract shall come from Transportation Alternative Program (TAP) designated through AHTD budget and compensation shall be paid in accordance with the contract documents.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF JONESBORO, ARKANSAS THAT:

Section 1: That the City of Jonesboro shall accept the low bid and enter into a contract with for the Crowley's Ridge Parkway: Craighead Forest Park Trail - Phase 2 (AHTD Job No. 100856) is Sugg Construction, Inc.

Section 2. That funding for the execution of the contract shall come from Transportation Alternative Program (TAP) and compensation shall be paid in accordance with the contract documents.
