A RESOLUTION EXPRESSING THE WILLINGNESS OF THE CITY OF JONESBORO TO PARTNER WITH THE ARKANSAS DEPARTMENT OF TRANSPORTATION FOR THE 2016-2020 STATEWIDE TRANSPORTATION IMPROVEMENT PROGRAM (STIP) JONESBORO AREA PARTNERING PROJECTS WHEREAS, the City of Jonesboro (City) has expressed interest in partnering with the Arkansas Department of Transportation (Department) on various state highway projects within the City as shown on Attachment A; and
