A RESOLUTION OF THE CITY OF JONESBORO TO ENTER INTO AN AGREEMENT WITH THE HUB HOMELESS RESOURCE CENTER, INC. FOR THE CDBG PUBLIC SERVICES PROGRAM.

WHEREAS, the City of Jonesboro, Arkansas, has allocated FY2019 CDBG Program funds for the HUB Homeless Resource Center, Inc. to receive \$20,000 for its HUB Program to assist individuals experiencing homelessness, reference RE-19:081; and,

WHEREAS, the City desires the subrecipient to carry out its stated objectives for the public services program as prescribed in the CDBG Annual Action Plan and in the scope of services within the said agreement; and,

WHEREAS, the subrecipient assumes responsibility for administering Federal funds in a manner consistent with underlying agreements, program objectives, and the terms and conditions of the Community Development Block Grant Program as described in this agreement.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS THAT:

SECTION 1: The Mayor, Harold Perrin, and City Clerk, Donna Jackson, are hereby authorized by the City Council for the City of Jonesboro to execute all documents necessary to effectuate said agreement.
