YOUNG SUBDIVISION OF LOT 5 OF PYLE SECOND ADDITION TO THE CITY OF JONESBORO, ARKANSAS. SUBJECT TO EXISTING EASEMENTS, BUILDING LINES, RESTRICTIONS AND ASSESSMENTS OF RECORD, IF ANY.

WHEREAS, Stanley Andrews/Michelle Nutt, the owner of record, was properly notified of a code violation at 1313 Pardew, Jonesboro, AR 72401, and refused to remove or correct the conditions identified by the code enforcement officer of the City of Jonesboro, Arkansas; and,
