RESOLUTION BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS, TO PLACE A MUNICIPAL LIEN ON PROPERTY LOCATED AT 1014 W. JEFFERSON, PARCEL 01-143134-35000, JONESBORO, ARKANSAS, OWNED BY JULIE MORRIS GOODWIN

LEGAL DESCRIPTION: A PART OF BLOCK 4 OF NISBETT'S SECOND ADDITION TO THE CITY OF JONESBORO, ARKANSAS, MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING 150 FEET WEST OF THE SOUTHEAST CORNER OF SAID BLOCK 4; THENCE NORTH 208 FEET TO AN ALLEY; THENCE WEST 94 FEET; THENCE SOUTH 208 FEET TO JEFFERSON AVENUE; THENCE EAST 94 FEET TO THE POINT OF BEGINNING, SAME BEING A PART OF WEST HALF OF THE SOUTHEAST QUARTER OF SECTION 13, TOWNSHIP 14 NORTH, RANGE 3 EAST, AND LYING AND BEING SITUATE IN THE WESTERN DISTRICT OF CRAIGHEAD COUNTY, ARKANSAS.

WHEREAS, Julie Morris Goodwin, the owner of record, was properly notified of a code violation at 1014 W. Jefferson, Jonesboro, AR 72401, and refused to remove or correct the conditions identified by the code enforcement officer of the City of Jonesboro, Arkansas; and,

WHEREAS, the code enforcement officer corrected the code violation using city funds in the amount of \$175.00; and,

WHEREAS, the City of Jonesboro seeks to perfect a lien against the affected property to cover the cost of the work pursuant to A.C.A 14-15-903; and,
