LEGAL DESCRIPTION: TRACT 4: THAT PART OF THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 36, TOWNSHIP 14 NORTH, RANGE 3 EAST, DESCRIBED AS FOLLOWS: BEGINNING AT THE SOUTHWEST CORNER OF SAID NORTHWEST QUARTER OF THE NORTHEAST QUARTER, RUN THENCE NORTH 88 DEGREES 59' 05" EAST 428.13 FEET TO THE TRUE POINT OF BEGINNING, RUN THENCE NORTH 88 DEGREES 59' 05" EAST 876.48 FEET, RUN THENCE NORTH 0 DEGREES 00' 12" WEST 533.59 FEET, RUN THENCE SOUTH 88 DEGREES 58' 48" WEST 1164.40 FEET, RUN THENCE SOUTH 21 DEGREES 06' 48" WEST 121074 FEET, RUN THENCE NORTH 89 DEGREES 29' 13" EAST 328.36 FEET, RUN THENCE SOUTH 1 DEGREE 01' 52" EAST 417.76 FEET TO THE TRUE POINT OF BEGINNING, CONTAINING 11.54 ACRES, MORE OR LESS. SUBJECT TO ALL EASEMENTS OF RECORD.
