LEGAL DESCRIPTION: ALL OF LOT 18D OF THE FIRST REPLAT OF PART OF BLOCK "G" OF MARLO ACRES 6TH ADDITION TO JONESBORO, ARKANSAS, LESS AND EXCEPT THE FOLLOWING TRACT: BEGIN AT THE NORTHWEST CORNER OF LOT 18D OF FIRST REPLAT OF A PART OF BLOCK "G" OF MARLO ACRES 6TH ADDITION TO JONESBORO, ARKANSAS: THEN SOUTH 36 DEGREES 10' WEST ON THE NORTHWESTERLY LINE OF AFORESAID LOT 18D, 66.7 FEET TO A CORNER OF AFORESAID LOT 18D; THENCE SOUTH 2 DEGREES 38' EAST ON THE WEST LINE OF AFORESAID LOT 18D; 13 FEET TO THE SOUTHWEST CORNER OF AFORESAID LOT 18D; THENCE NORTH 30 DEGREES 07' EAST 77.26 FEET TO THE POINT OF BEGINNING; SAID EXCEPTION CONTAINING 271 SQUARE FEET.
