BRIDGE, PARCEL 01-144181-55600, JONESBORO, ARKANSAS 72401, OWNED BY PATRICIA WILLIAMS LEGAL DESCRIPTION: BLOCK 10, LOT 21, OF THE MATTHEWS ADDITION IN THE CITY OF JONESBORO, CRAIGHEAD COUNTY, ARKANSAS; COMMONLY KNOWN AS 129 N. BRIDGE STREET, JONESBORO, ARKANSAS.

WHEREAS, Patricia Williams, the owner of record, was properly notified of a code violation at 129 N. Bridge, Jonesboro, AR 72401, and refused to remove or correct the conditions identified by the code enforcement officer of the City of Jonesboro, Arkansas; and,
