ALLIS, PARCEL 01-01-144181-01600, JONESBORO, ARKANSAS 72401, OWNED BY MICHAEL & BARBARA PEARSON** LEGAL DESCRIPTION: PART OF THE NE ¼ OF THE NE ¼ OF SECTION 18, IN TOWNSHIP 14, NORTH, OF RANGE 4, EAST, BOUNDED AS FOLLOWS: BEGINNING FIVE HUNDRED SEVENTY FOUR FIFTHS FEET NORTH OF THE SOUTH EAST CORNER OF SAID TRACT; THENCE WEST THREE HUNDRED AND FIFTEEN FEET; THENCE NORTH ONE HUNDRED SIXTY THREE AND ONE FIFTH FEET; THENCE EAST THREE HUNDRED AND FIFTEEN FEET; THENCE SOUTH ONE HUNDRED AND SIXTY THREE AND ONE FIFTH FEET TO THE POINT OF BEGINNING.

WHEREAS, Michael & Barbara Pearson, the owners of record, were properly notified of a code violation at 346 & 348 N. Allis, Jonesboro, AR 72401, and refused to remove or correct the conditions identified by the code enforcement officer of the City of Jonesboro, Arkansas; and
