WHEREAS, the City of Jonesboro, Arkansas owns and maintains Joe Mack Campbell Sports Complex located at 3021 Dan Avenue and Southside Softball Complex located at 5003 Stadium Blvd;

WHEREAS, Centennial Bank is seeking sponsorship recognition on one soccer field at the Joe Mack Campbell Sports Complex and one outfield sign at Southside Softball Complex; and

WHEREAS, Centennial Bank is sponsoring the field and outfield sign for the sum of \$12,500 for a period of 5 years;

NOW, THEREFORE BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS

SECTION 1: That the City of Jonesboro, Arkansas shall contract with Centennial Bank for the sponsorship of a field at Joe Mack Campbell Sports Complex and the outfield fence sign. A copy of said contract is attached as Exhibit A.
