A RESOLUTION OF THE CITY OF JONESBORO, ARKANSAS TO CONTRACT WITH ACADEMY SPORTS AND OUTDOORS FOR SPONSORSHIP OF TWO ATHLETIC FIELDS AT THE JOE MACK CAMPBELL SPORTS COMPLEX AND ONE SIGN AT THE CONCESSION STAND WHEREAS, the City of Jonesboro, Arkansas owns and maintains Joe Mack Campbell Sports Complex located at 3021 Dan Avenue; and

WHEREAS, Academy Sports and Outdoors is seeking sponsorship recognition on one soccer field and one baseball field at Joe Mack Campbell Sports Complex and one concession stand at Joe Mack Campbell Sports Complex; and

WHEREAS, Academy Sports and Outdoors is sponsoring the fields and concession stand sign for the sum of \$18,000 for a period of 3 years;

## NOW, THEREFORE BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS

SECTION 1: That the City of Jonesboro, Arkansas shall contract with Academy Sports and Outdoors for the sponsorship of one baseball field and one soccer field at Joe Mack Campbell Sports Complex and one
