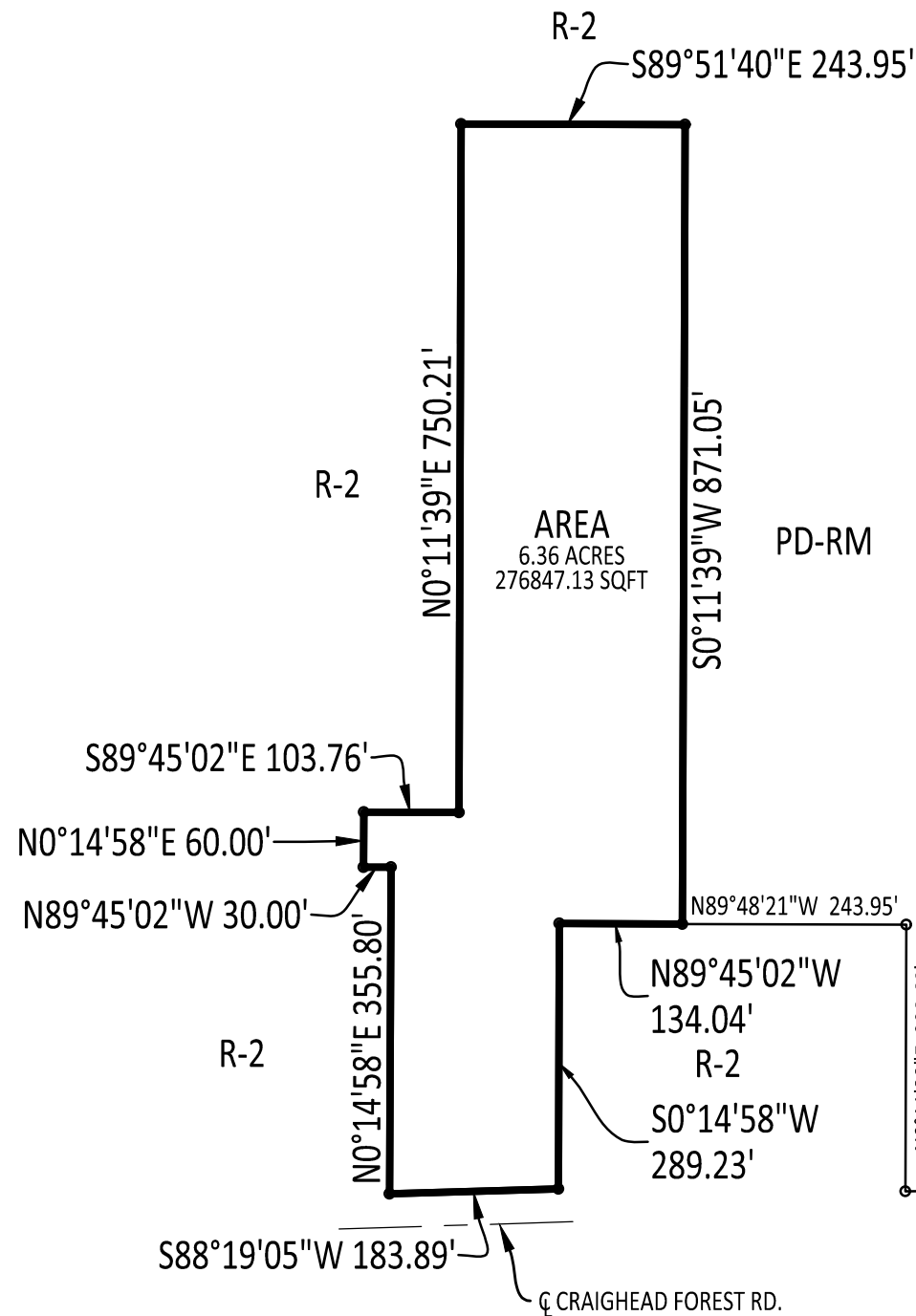

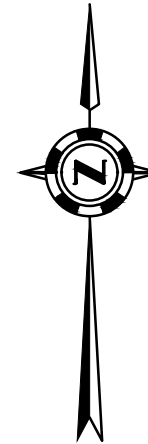
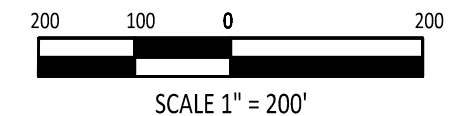
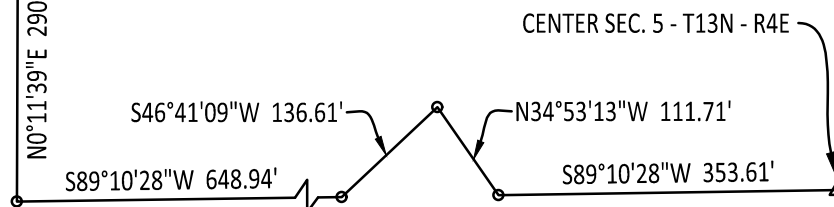


VICINITY MAP
