DEAR MAYOR BRODELL:

WE HAVE RECEIVED A PROPOSED RESOLUTION FROM DONNA JACKSON THAT WAS FILED FEBRUARY 16, 1994 BY CAPTAIN E.R.RAINEY FOR CHIEF FLOYD JOHNSON TO LOCATE CONTROL DEVICES.

WE HAVE STUDIED THESE INTERSECTIONS AND RECOMMEND THE FOLLOWING:

- 1. ON SPURLOCK LANE AT RICHARDSON DRIVE
- 2. ON KRISTAL DRIVE AT RICHARDSON DRIVE
- 3. ON FAIRPARK BOULEVARD AT RACE STREET
- 4. ON SPENCE CIRCLE AT RACE STREET
- 5. ON NEEDHAM STREET AT SPENCE CIRCLE

WE DO NOT RECOMMEND CONTROL DEVICES ON RACE STREET AT BROWN'S LANE FOR THE FOLLOWING REASONS:

- 1. ON SEPTEMBER 7, 1993 THE CITY COUNCIL, ACTING ON THE RECOMMENDATIONS OF THE CITIZENS PLANNING COMMITTEE, NAMED RACE STREET A MINOR ARTERIAL.
- 2. AS A MINOR ARTERIAL RACE STREET IS EXPECTED TO BE USED FOR THRU TRAFFIC EAST AND WEST.
- 3. BROWN'S LANE IS A SHORT STREET AND TERMINATES
 ON THE NORTH END AT HIGHLAND DRIVE AND ON THE SOUTH
 END AT THE ACCESS ROAD.
- 4. THE STOP SIGNS SHOULD BE PLACED ON BROWN'S LANE.
 ERNIE PETERS WAS IN JONESBORO ON THURSDAY AND FRIDAY TO LOOK

STOP INTERSECTION WITH THE STOP SIGNS ON THE ACCESS ROAD AND
MINITRE TO ALLOW TRAFFIC ON RACE STREET TO MOVE TO HIGHWAY #1B
(OLD HARRISBURG HIGHWAY).
