Chairman Frierson stated the purchase price is \$24,000 and bidding is being waived because the vehicle is used. Mayor Perrin noted the dump truck will be used in the cemeteries to move the fill dirt. He added the City's mechanics have looked over the truck and the item is in the budget.

A RESOLUTION TO CONTRACT WITH ARKANSAS RUSH SOCCER CLUB

Assistant Parks Director Wixson Huffstetler explained this contract will allow RUSH Soccer out of Conway to run the City's L-3 Competitive League program since the City doesn't have the staff or coaches to run the program. He added RUSH will pay the City a fee for every kid that plays in their program and a usage fee. He stated RUSH will have two fields to play on along with a backup field and the dates for the fields are April 1 through June 1 and September 1 through November 1.

Mayor Perrin stated the Craighead County Soccer Association entered into a contract with RUSH last year and the City never received the money for the use of the fields,

but the City received full payment from the Board Chairman of RUSH few weeks ago.

JETS Director Steve Ewart answered yes and they met with IT to make sure everything was correct. He added the City received two proposals and Routematch had the lowest bid for the 5 year cost and maintenance. He stated this will allow the city to coordinate transportation with the East Arkansas Area Agency on Aging and other Human Service agencies.
