IN THE MATTER OF CLOSING A TEN FOOT ALLEY BETWEEN CUBA AVENUE AND DEWEY STREET AND CLOSING THE EAST 115 FEET OF SCHLEY STREET FROM ITS INTERSECTION WITH DEWEY STREET.

# PETITION TO VACATE AND ABANDON STREET AND ALLEY

Comes the undersigned petitioners, being the abutting land owners and for their Petition, state:

1. The petitioners have attached to this Petition and made a part of this Petition the plat of Block 5 and 8 of Watt's Addition to the Town of Nettleton, Arkansas as recorded in Deed Record 18, page 621 at Jonesboro, Arkansas. The ten foot alley running between Cuba Avenue and Dewey Street is no longer needed for public purpose and the abutting property owners desire that the City Council abandon and vacate the ten foot alley.

The petitioners state that Schely Street west of Dewey Street running in an easterly direction for approximately 125 feet is no longer needed for public purpose and should be closed and vacated by the City Council.

- 2. The undersigned petitioners are all of the abutting property owners to the alley in question and to that portion of Schely Street in question.
- 3. The petitioners respectfully request that the City Council pass a resolution directing the City Clerk to give notice by publication once a week for two weeks in some newspaper published in Craighead County having a circulation in the City of Jonesboro advising property owners who may be effected by the vacating and closing of the above street and alley that on a day certain the City Council for the City of Jonesboro, Arkansas will hear this Petition and determine whether such street and alley should be abandoned and vacated and whether all abutting property owners or other persons directly interest in the closing and vacating of the street and alley have consented to such abandonment and whether the abandonment and closing of the street and alley in question would be in the best interest of the City of Jonesboro, Arkansas.
- 4. This Petition is hereby presented and filed with the City Council for the City of Jonesboro, Arkansas pursuant to Ark. Stat. Ann. §19-3828.
