- 1. That the plaintiff, City of Jonesboro, Arkansas, herein filed its complaint in condemnation alleging its right to condemn a drainage easement across the lands of the defendants and the mortgagee under the power of eminent domain, and deposited into the registry of the court the sum of \$2,230.00 as just compensation for the taking of the land of the defendant.
- 2. That plaintiff is entitled to a permanent easement on said land of the defendants to construct, maintain and utilize improvements.
- 3. That the defendants Steven K Smallman and Heather K.Pierce Smallman, defendants and Wells Fargo National Bank Association, Mortgagee are entitled to the funds deposited into the registry of the court for the taking of their land. That the sum of \$2,230.00 deposited shall be given to the defendants and the mortgagee.

Now comes the plaintiff, the City of Jonesboro, by and through its City Attorney, Phillip Crego and for its Complaint in Condemnation, states and alleges:

- 1. The plaintiff, City of Jonesboro, Arkansas, is a city of the first class under the laws of the State of Arkansas.

 Defendant, STEVEN K SMALLMAN AND HEATHER K PIERCE SMALLMAN are citizens owning and operating property in Craighead County, Arkansas, which is the subject of this action. Defendant Wells Fargo National Bank Association is a lending entity doing business in Craighead County, Arkansas.
- 2. The plaintiff, in the exercise of its governmental powers and authority, has contracted for improvements within the City of Jonesboro. Additional easements and right of ways for this work of improvement are needed from property owners, including the defendant's property.
- 3. The description of the property owned by the defendant which is required for plaintiff's purposes is as follows:

'A part of Lot 23 Block 2, Section 30, Township 14. N Range 04 of Ridgecrest Additon 30' x 74.3'feet or 2229 square feet, more or less, and also known as 504 Parkview; situated in the City of Jonesboro, Craighead County, Arkansas.

- 4. Pursuant to provisions of state law, including Arkansas Code Annotated 18-15-309, plaintiff is vested with the power of eminent domain and is authorized to enter upon private property for the construction of its designed improvements and is proceeding under eminent domain to acquire a permanent easement, along with temporary easements described above, for the purposes related. The acquisition of easement for these purposes is a necessary public use providing for improvements in the City of Jonesboro.
- 5. Plaintiff has had this property appraised, with the appraisal report indicating that there were no damages to the defendant owner by reason of the proposed taking of said easement, in that the land owned by the defendant, which is the subject of this action, has an appraisal value of \$2,230.00, Therefore Plaintiff suggests a sum of (\$2,230.00) as just compensation under these circumstances, and plaintiff is entitled to immediate entry upon these lands for the purposes stated upon the filing of this complaint, deposit into the registry of the Court of the sum mentioned as just compensation and notice of this action to defendant. Plaintiff herewith deposits into the registry of the

Court the sum of (\$ 2,230.00) as such just compensation.

6. That defendant, Wells Fargo National Bank Association may claim an interest in this property by virtue of a mortgage held by it on this property.

WHEREFORE, plaintiff prays that the above described lands be condemned for the aforesaid public use, both for temporary easements and permanent easement, and that defendant's damages be assessed at (\$ 2.230.00) for the taking of such land for these uses, and that this Court issue its order for immediate entry on the above described land by plaintiff for the purposes stated above.
