The City in no way guarantees any amount or any number of jobs under this bid. The bid will be for a twelve (12) month period starting April 15, 2004 and ending on April 14, 2005. The City may terminate this contract by 15 days written notice if it is found that the awarded contractor has failed to meet his/her obligations as directed by these specifications and no monetary damage will be given for unfinished job.</p> <p>Price to perform demolition as per specifications below (1500 sq ft) _____</p> <ol style="list-style-type: none"> 1) The Contractor shall begin demolition within 2 (two) working days from the date the City gives directions and location of said demolition, weather permitting. 2) All debris will be removed from the property by the contractor. Tipping fees will be waived at the landfill for successful bidder on city jobs only. 3) After demolition, the property will be smoothed and leveled. In the even that a hole is left on the property, it will be filled by the contractor at his/her expense as a part of this bid. 4) The bidder will attach proof of liability with this bid. 5) The bid is based on each structure being 1500 square feet or less. For anything larger, an additional \$500 per 500 square feet will be paid to the contractor (\$1/sq ft). 6) The City of Jonesboro will not be liable for any accidents in the performance of the work performed by contractor. 7) The Contractor will be responsible for any and all damages done to property or properties which are not in the scope of the demolition. 8) The City will review all bidders and evaluate the work performance to determine the best and appropriate bidder. 9) Contractor will provide proof of being bonded. 10) Contractor will have a valid and paid Privilege License with the City of Jonesboro or a reciprocating municipality. 11) A list of all equipment owned or leased shall be attached to this bid for evaluation by the City. 12) The City will inspect all work after completion of each demolition and approve the job before completing paperwork and scheduling payment during normal bill paying schedules by the City.
