



LEGAL DESCRIPTION:

Begin at a pipe for the Southeast corner of the intersection of Melrose Street with Word Cove, said street intersection being the Northwest corner of said Lot 98, College Place Subdivision; then run South 89°38' East along the North line of said subdivision 455.60 feet to an iron pipe for the Northeast corner of said Lot 196 on the West line of Marshall Street; then run South 00°44' West along the East line of Marshall Street 400.00 feet to an iron pipe for the Southeast corner of said Lot 181; then run North 89°38' West along the North line of Lot 181 a distance of 220.00 feet to an iron pipe for the Southwest corner of said Lot 101; then run South 00°44' West 100.00 feet; then run South 89°38' East 220.00 feet to an iron pipe on the West line of said Marshall Street; then run South 00°44' West 22.90 feet to an iron pipe on the North line of Johnson Ave.; then South 77°23' West along said North line Johnson Ave. 226.10 feet; then South 80°28'20" West along said North line Johnson Ave. 15.52 feet to an iron pipe; then run North 00°44' East 210.00 feet to an iron pipe; then run South 80°28'20" West 223.07 feet; then run North 00°44' East along the East line of Melrose 405.35 feet to the point of beginning, being 4.41 acres, more or less, and including 570 linear feet, more or less of a 15.60 foot wide platted alleyway, AND lots 197 - 213 and all that part of lots 214, 131 and 132 West and North of Johnson Avenue, being 2.16 acres, more or less.
