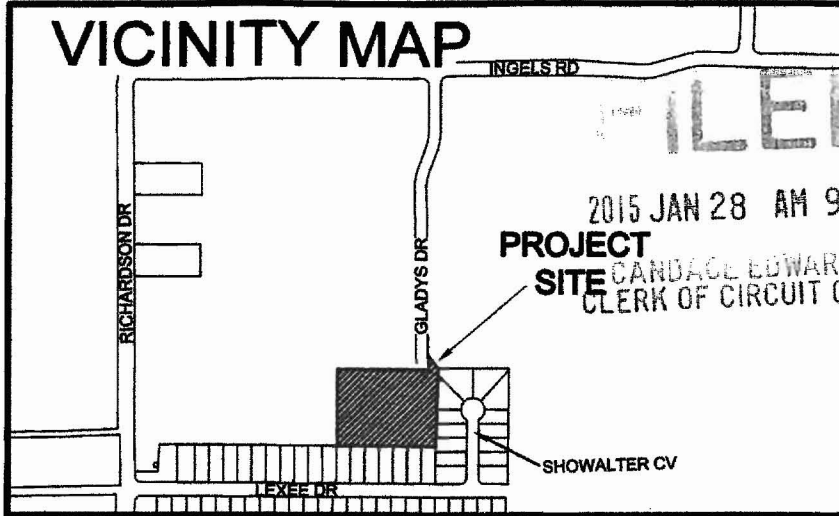


VICINITY MAP



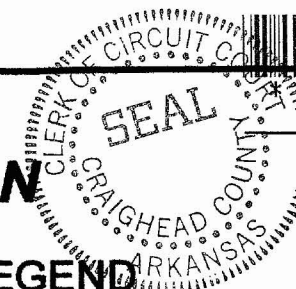

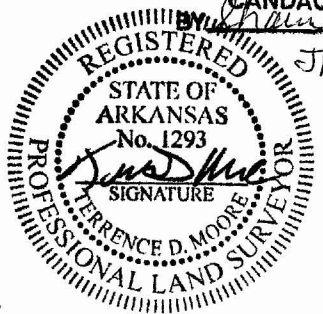

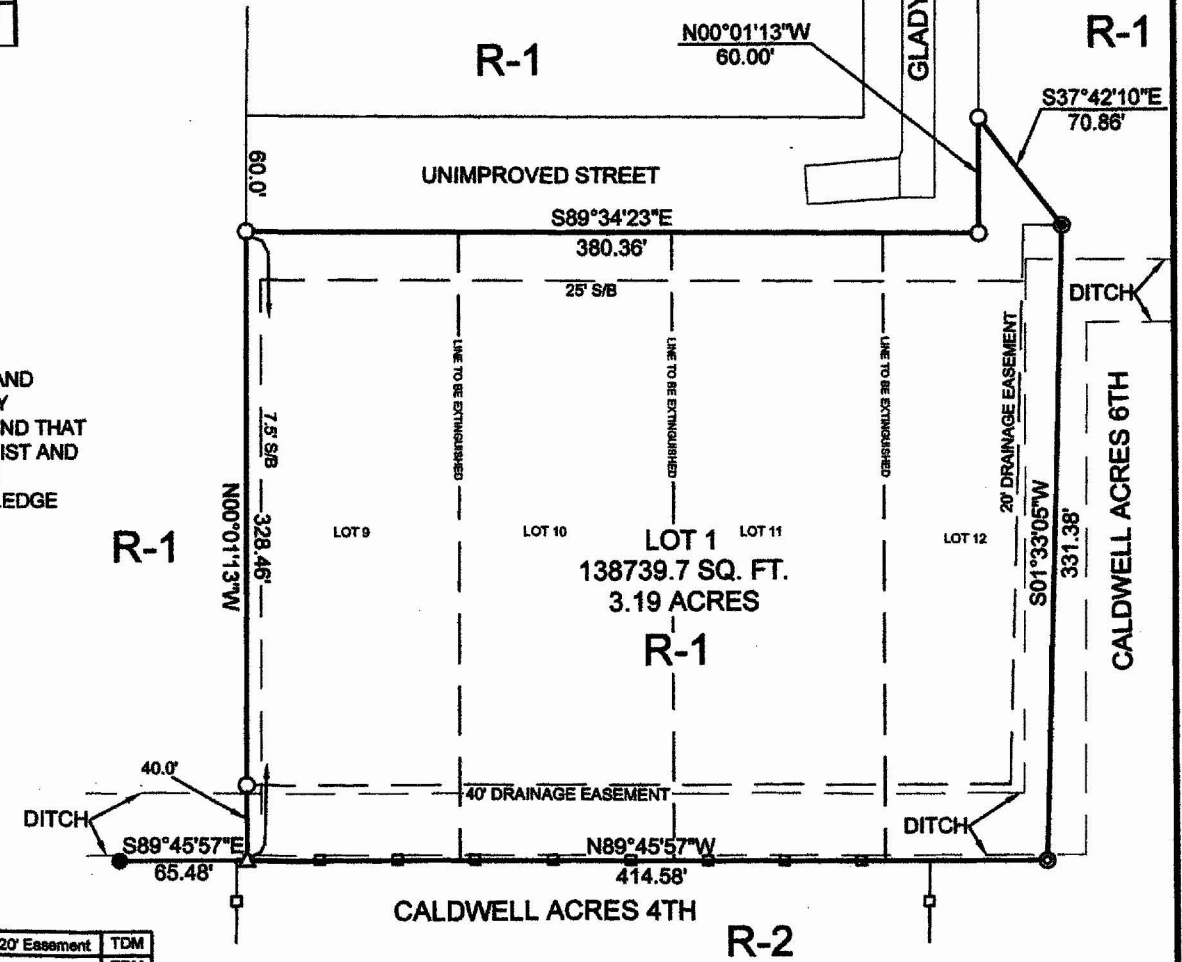
