Dear Ms. Jackson,

After numerous calls and e-mails with Janiece Robbins, Tax Collector for Craighead County with no resolved explanation. I'm seeking to appeal the lien for demolition of property at 811 E. Washington Parcel #01-144184-28100 not be considered taxes due from 2008 and created a block on the property to prevent the payment of taxes due for 2009.

Attached, notice from Jonesboro Code Enforcement Officer, Ron Shaver advised that a meeting on October 20, 2009, the City Council of the City of Jonesboro adopted a resolution finding and declaring the subject property to be a nuisance that must be repaired or removed with in 30 days from the date of condemnation by City Council. The City will take actions required to abate the nuisance. A lien will be placed on the property.

By the time the City Council adopted a resolution to repair or remove the nuisance, the Jonesboro Code Enforcement Officer, Ron Shaver had already razed and removed the house July 17, 2009. The lien was placed on the property, September 9, 2009 by Ron Shaver.

Please be advised not all of the owners of the property were given the opportunity to resolve the nuisance problem before the property was demolished/removed and went to the City Council to adopt resolution. Nor was a bill for cost of demolition/removal of the property received.

Attached, is a summary of taxes due, dated December 20, 2010 from the Tax Collector's Office, show unpaid taxes in the amount of \$3,934.42 due from 2008, and unpaid taxes due from 2009.

Attached, the 2008 Tax Statement Payable in 2009, postmarked April 15, 2009 for \$153.27. Payment made September 9, 2009 via credit card.

Attached, Invoice for demolition of the property from Becky Sharp, City Collector, dated May 3, 2010, \$3,559.08. This should have nothing to do with taxes due for 2008.

I received 2009 Tax Statement payable in 2010 advising to call "Tax Delinquent". I called and was told there is a lien on the property unpaid from 2008 taxes and couldn't pay taxes due for 2009 until the lien on the property was paid.

The house on the property was demolished July 17, 2009 and the lien on the property was placed September 9, 2009 without due process and approval of the City Council of Jonesboro, October 20, 2009.

My family and I could possibly forfeit ownership of the property because of inconstant explanations of taxes due. The lien on the property shouldn't have any thing to do with personal or real estate taxes due.

Your assistance in this matter would be greatly appreciated.

Dear Mr. McCullough

At its meeting on October 20, 2009, The City Council of the City of Jonesboro adopted a resolution finding and declaring the subject property to be a nuisance that must be repaired or removed. A copy of the Condemnation Resolution is enclosed.

You are hereby directed to board and secure the structure at all times until the structure is brought into full compliance with applicable building or abatement codes or until such time as the structure is razed and removed. Boarding and securing the structure does not relieve the owner of the requirement to diligently repair, rehabilitate or demolish and remove the structure.

If you decide to abate this nuisance you must obtain necessary permits and commence abatement work with thirty (30) days from the date of condemnation by City Council. The permits shall expire forty-five (45) days from the date of issuance. Abatement work is expected to be completed before the permits expire. A fine of not less than \$250 nor more than \$500 may be imposed and an additional fine of \$250 for each day thereafter.(Ord. 11.32.12)

In the event you have not obtained necessary permits and commenced work to abate the nuisance with in thirty (30) days from the date of condemnation by City Council the City will take actions required to abate the nuisance. All costs of abatement will be billed to you as owner of the property. Payment of this bill will be actively pursued. A tax lien will be placed on the property until payment is received in full. A fine of not less than \$250 nor more than \$500 may be imposed and an additional fine of \$250 for each day thereafter.(Ord. 11.32.12)




