

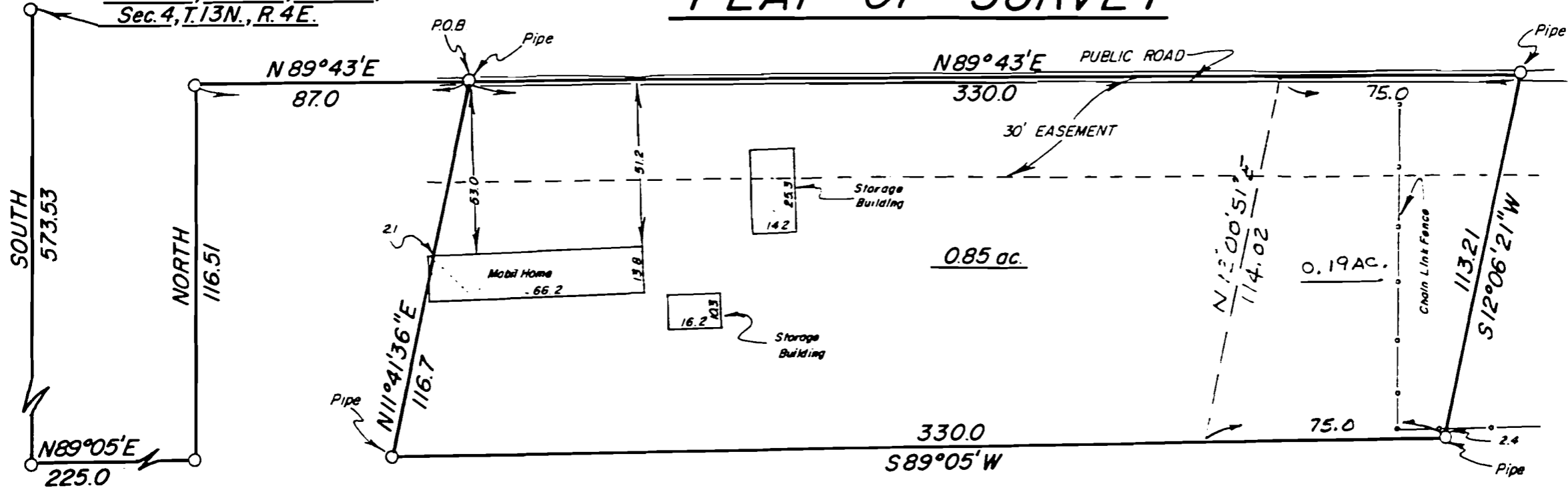

Sec. 4, T. 13N., R. 4E.



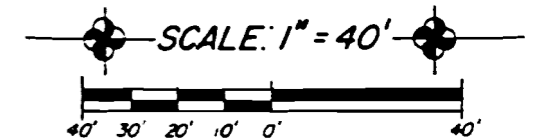
CERTIFICATE OF SURVEY
