ORDER OF ANNEXATION

On this 13th day of June, 1977, comes on to be heard the petition of property owners who are named in the Petition, praying for the annexation of the following described lands:


A part of the Northeast Quarter of the Northeast Quarter of Section 32, Township 14 North, Range 4 East, being more particularly described as follows: Begin at the Northeast corner of Section 32, Township 14 North, Range 4 East; thence West on the Section line 142.9 feet to the Southwest-erly right of way line of U. S. Highway No. 63 Bypass the point of beginning proper; thence continue West on the Section line 1021.1 feet; thence South 1 degree 09' West 445.5 feet; thence South 0 degrees 54' West 551.5 feet; thence North 89 degrees 56' East 740.8 feet; thence North 1 degree 09' East 210 feet; thence North 89 degrees 56' East 45 feet; thence North 1 degree 09' East 428.28 feet; thence North 89 degrees 56' East 293.85 feet to the West right of way line of Arkansas State Highway No. 173; thence North 3 degrees 27' West on said right of way line 149.3 feet; thence North 0 degrees 52' East on said right of way line 156.3 feet to the beginning of U. S. No. 63 Bypass right of way; thence North 43 degrees West on said right of way line 70.3 feet to the point of beginning proper, containing 20.1 acres.

to the city of Jonesboro, Craighead County, Arkansas. From the evidence adduced, the Court finds that the above described property is contiguous to and adjoins the city limits of Jonesboro, Arkansas; Petitioners constitute all the real estate owners of the above described lands, a majority of which is required by Arkansas Statutes 19-301; notice of the time, place and date of this hearing has been published once a week for three consecutive weeks in the Jonesboro Sun, a newspaper of general circulation in Craighead County, Arkansas, the first publication thereof was thirty days before this hearing, and the petition herein has been filed for not less than thirty days.

The Court finds that the statements in the petition are true, that the territory sought to be annexed has been accurately described, an accurate

map of lands have been made and filed, and that the lands described above should be annexed, and that no objections have been made to said annexation.

IT IS THEREFORE, considered, ordered and adjudged that the prayer of the petitioners is hereby granted, and that the above described lands are hereby annexed to and made a part of the City of Jonesboro, Craighead County, Arkansas.
