ORDER OF CONFIRMATION OF ANNEXATION

On this 8 day of July, 1985, comes on for a hearing before the Court the above styled cause and matter now appearing for the approval and confirmation of the annexation of said lands heretofore annexed to the City of Jonesboro, Arkansas by order of this Court dated January 24, 1983. The petitioner appears by and through its attorney, Judy A. Henson. The matter is heard upon the pleadings and orders with exhibits thereto, filed herein, the affidavit and certificate of the Circuit Clerk of Craighead County, Arkansas, certifying that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County to prevent the annexation of said lands and territory herein, from all of which, together with other things and matters before the Court, the Court doth find:

That said lands herein were annexed to the City of Jonesboro by order of this Court dated January 24, 1983, and that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County, Arkansas, to prevent said annexation within thirty days from the date of said order of annexation and that said annexation was in all things done in conformity with the laws of the State of Arkansas and therefore should be approved and confirmed; that said territory should be accepted by the City of Jonesboro, Arkansas.


That said lands and territory annexed to the City of Jonesboro, Arkansas are described as follows, to-wit:

- Parcel A: The Northwest Quarter of the Southwest Quarter of Section 25, Township 14 North, Range 4 East, containing 40 acres.
- Parcel B: The Southwest Quarter of the Southwest Quarter of Section 25, Township 14 North, Range 4 East, containing 40 acres.
- Parcel C: The Southeast Quarter of the Southwest Quarter of Section 25, Township 14 North, Range 4 East, containing 40 acres.

Parcel D: The Southwest Quarter of the Southeast Quarter of Section 25, Township 14 North, Range 4 East, containing 40 acres.

Parcel E: That part of the Southeast Quarter of the Southwest Quarter of Section 26, Township 14 North, Range 4 East, lying North and East of the Burlington Railroad right of way, containing 34 acres.

It is, therefore, by the Court, CONSIDERED, ORDERED, ADJUDGED and DECREED that annexation of said lands and territory herein to the City of Jonesboro, Arkansas, be in all things approved and confirmed and the proceedings before this Court be and are hereby confirmed. The Clerk of this Court be and is hereby authorized and directed to certify one copy of the plat to such annexed territory with one copy of this Order of the Court and the Ordinance of the City of Jonesboro, Arkansas, and forward one copy of each to the Secretary of State who shall file and preserve the same and shall forward one copy of this Order to the Director of the Tax Division of the Arkansas Public Service Commission who shall file and preserve the same and shall notify all utility companies having property in said municipality of this annexation of property and the Clerk is directed to forward a certified copy of this order to the City of Jonesboro, Arkansas.
