AN ORDINANCE TO WAIVE COMPETITIVE BIDDING AND AUTHORIZE THE

PURCHASE OF DIGITAL CAMERA EQUIPMENT FOR POLICE UNITS

Sponsors: Police Department

Police Chief Michael Yates explained the City received a Department of Justice grant to purchase computer and car camera systems in 2005 or 2006. He added the system that was purchased is beginning to have problems and the warranties have expired. He noted it is expensive to repair the current camera system at a cost of approximately \$900 to \$1,800 each. He stated the Police Department is going to use a different setup, where the computer and camera system are separate from each other. He added they already have a server that can be used for the new equipment. He noted the City bid out this system in 2009 and only one company bid on the system. He explained the money is in the budget, but due to the system cost being so large they are required to pass an ordinance. He stated this ordinance is for only 9 Mobile Vision systems.

Councilman Moore inquired if this is the same company that bid on the systems in 2009. Chief Yates answered yes.

Chairman Johnson questioned if this needs to be placed on tonight's Council agenda. Chief Yates answered he would prefer it to be placed on tonight's Council agenda due to the cost of repairing the systems being so high. He added this ordinance has an emergency clause.

A motion was made by Councilman Chris Moore, seconded by Councilman Mikel Fears, that this matter be Recommended to Council . The motion PASSED by a unanimous vote

Code Enforcement Officer Ronnie Shaver explained this structure has been considered a nuisance.
