# 2016 Valley View Drive Parcel #4 Right-of-Way

Whereas, Trustees of Christian Valley Church are the owners of land in Craighead County, Arkansas, as described below, and the City of Jonesboro ("the City"), a municipal corporation of the State of Arkansas, is the owner of adjoining land;

Whereas, Trustees of Christian Valley Church and the City have agreed upon a right-of-way for construction and maintenance of a street across the land of Trustees of Christian Valley Church in favor of the City and in favor of the land of the City.

Now, therefore, be it agreed between Trustees of Christian Valley Church and the City on the day of ware 2005.

1. Trustees of Christian Valley Church in consideration of the agreement hereinafter made by city, grant to the City a right-of-way for construction and maintenance of a street over the land of Trustees of Christian Valley Church in City of Jonesboro, Craighead County, Arkansas, or particularly described as follows:

#### Right of Way Acquisition Area I
