Dear Property Owner:

According to county records you are the owner of the subject property. Please be advised that the structure on this property has been inspected by the City Building and Code Enforcement inspectors and, has been found to be unfit for human habitation by virtue of its dilapidated and unsanitary condition. This property poses a hazard to the public and is a nuisance against public health.

Within 10 (ten) calendar days from the date of this letter you are required to respond to this notice in writing, indicating you intention to either repair, re-inhabit, or raze and remove this structure. Should you choose to repair or rehab the structure, you will have to obtain a building permit and start work within 40 calendar days from the date of this notice. The building permit will be issued for a total of 45 calendar days at which time the repair or rehab work must be complete and able to pass all building, electrical, plumbing, and mechanical inspections.

If you decide to raze and remove this structure, removal and clean-up activities must be completed within 40 days of this notice.

If you decide not to repair or remove this structure, it will be necessary for the City Council to consider condemning the structure to ensure the repair, rehab, securing, and/or razing and removal of this nuisance. All costs involved in the condemnation process would be charged to you. Collection would be actively pursued.

THE HOME IS ON A BLOCK PIER FOUNDATION. THE SILT PLATE AROUND THE HOME IS ROTTEN AND FALLING APART. THIS IS CAUSING THE LOWER SIDING TO FALL OFF THE HOME PRIMARILY ON THE WEST SIDE OF THE HOME. THE SILT PLATE MUST BE REPLACED. MOST OF THE WINDOWS ARE BROKEN OR BOARDED. ANY BROKEN OR DAMAGED WINDOWS MUST BE REPAIRED OR REPLACED. THE SOFFIT ON THE REAR HALF OF THE HOME IS ROTTING AND FALLING OFF THE HOME. THE ROOF IS SAGGING AND HAS BROKEN AND MISSING SHINGLES. THE ENTIRE ROOF NEEDS TO BE REPAIRED OR REPLACED INCLUDING UNDERLAY, TAR PAPER, AND SHINGLES. THE ROOF IS LEAKING AND CAUSING DAMAGE INSIDE THE HOME. THE ENTIRE SHEETROCK CEILING INSIDE HAS FALLEN IN. THE SMELL OF MOLD AND MILDEW IS OVERPOWERING. IT CAN BE SMELT OUTSIDE OF THE HOME. THE INTERIOR OF THE HOME IS DESTROYED AND THE HOME IS NOT SECURE. THE HOME IS A HAZARD TO THE HEALTH, WELFARE, AND SAFETY OF THE PUBLIC. THE HOME SHOULD BE RAZED IMMEDIATELY TO ENSURE THE SAFETY OF LOCAL CHILDREN AND OTHER CITIZENS, NOT TO MENTION THE BLIGHT TO THE COMMUNITY.
