Mayor Perrin reported on the following items:

He visited Springfield, Missouri, along with several others last week to view the

Miracle Field. They hope to have a project timeline done by the end of the month.

The Enhancement Grant for the Phillips Drive sidewalks has been signed. They have visited with CWL for special lighting in that area.

The City received almost \$234,000 in Safe Routes to School Grant funding. They are drafting plans and hope to start on that this week.

Fire Station #4 is on time with its scheduled completion, which should be February 15.

ADEQ extended the City's consent order until May 31st. There should be no problem with getting the work done before then.

The spatial study is underway. They hope to get something back from the architects this month.

E-911 has hired two call takers. They will start their orientation tomorrow. It will take 30 to 60 days before they are certified by the state.

Departmental goals and objectives are completed. If any Council members would like a copy, he will send it to them. Around February 1, department heads should start making presentations concerning their objectives.

Filming needs to be completed for Channel 24. He asked for everyone to contact Mr. Jack Turner in order to complete the videos by Friday.
