Associated Engineering, LLC, herein known as AE (the "Consultant"), is pleased to submit this Scope of Work and Fee Proposal to the City of Jonesboro, herein known as the City (the "Client"), for providing Professional Engineering Services for the above referenced project. The project is more specifically defined as a street improvement/extension of Bowling Lane from University Heights School north and east to Hill Drive. The proposed project is some 1,800 l.f. in length and will consist of widening existing streets and new construction. This scope of work is based on a set budget of \$ 400,000.00.

SCOPE OF SERVICES

1.) Boundary determination and topographic survey of the project limits.

Perform necessary boundary and topographic surveys to establish existing subdivision/right of way limits within the project scope. Locate existing street and ground elevations, drainage structures, utilities, natural features within the proposed right of way.

- 2.) Provide proposed alignment alternatives and rights of way needed for discussion.
- 3.) Provide report with estimated costs and presentation to City Staff and City Council for proposed conceptual design of improvements.
- 4.) Develop civil plan set for approved conceptual design. Develop COJ approved contract specifications. Provide COJ bidding process of design plan set for construction. Coordination with City Staff for bidding process and construction award through City Council.
- 5.) Provide civil inspection of construction in accordance with civil plan set. Fees to be determined based on final construction plans and schedule.

- A. Geotechnical report to include grading and pavement recommendations.
- B. Any changes to the layout, changes to the scope of work or additional services requested by the Client shall be billed on an hourly basis.

- Coordination of Environmental Survey, Traffic Survey and Geotechnical Consultants.
- Off-site roadway design or widening improvements.
- Detention pond surveys and/or construction approval.
- NPDES Permit, as required.
- Off-site utilities.
- Governmental approval/permit for wetlands and floodplain mitigation.
- Water distribution report.
- Zoning/rezoning of property.
