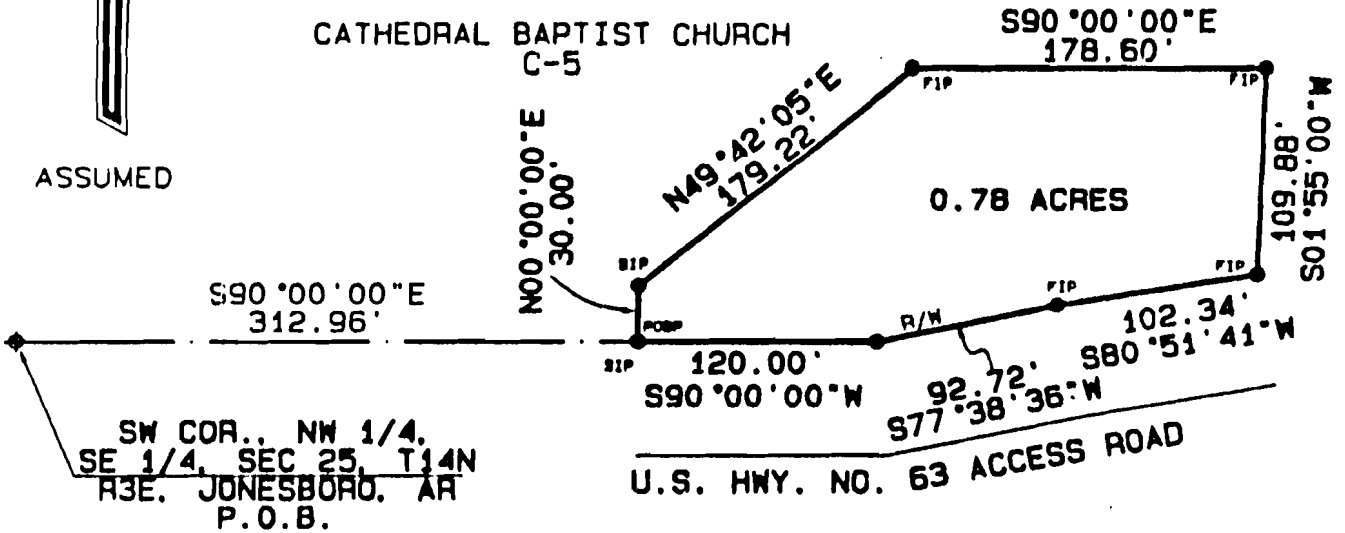


VICINITY MAP

NO. 63 ACCESS ROAD; THENCE S80°51'41"W ALONG SAID RIGHT OF WAY LINE 102.34'; THENCE S77°38'36"W ALONG SAID RIGHT OF WAY LINE 92.72'; THENCE S90°00'00"W ALONG SAID RIGHT OF WAY LINE 120.00' TO THE POINT OF BEGINNING PROPER CONTAINING 0.78 ACRES MORE OR LESS SUBJECT TO ALL RIGHTS OF WAY AND EASEMENTS OF RECORD.

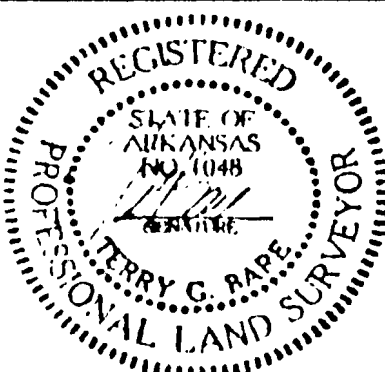
