AN ORDINANCE TO REPEAL AND ADOPT ORDINANCES RELATING TO DOWNTOWN PARKING IN THE CITY OF JONESBORO

**Sponsors:** Police Department

*Police Chief Rick Elliott explained the Parking Authority in regards to this ordinance. It's basically cleanup with some language. The old ordinance was antiquated. Parking fees had originally gone to some out of state company that collected the money and sent it back to the city. It also redesignated some parking lots as free parking lots. There will also be two parking lots downtown for employees to park in without penalty. The changes are listed in their packet.*

*Councilman McClain asked if there is someone who monitors the two hour parking. Police Chief Elliott answered yes. The city's parking enforcement officer was struck by a vehicle a few months ago. Hopefully she'll be returning to work in May. They are hoping to get this done before she starts back to work so when she does come back they can restart enforcement activities downtown. Up to this point, they haven't written any tickets downtown. She has spent her time visiting local merchants to see what direction they want to go in with the parking. That information, along with information from Downtown Jonesboro Association Executive Director Hailey Knight,*

was presented to the Parking Authority. These were the changes that came from that information.

Councilman Vance asked what is designated as the downtown area. Police Chief Elliott answered from the court house up to the bridge. Councilman Vance explained the reason he asked is because there's some parking on Matthews that there's been some problems with in the past. Police Chief Elliott added it's not limited to just the area he described. It's just the general downtown vicinity. That's just her general walking area. Councilman Vance further explained when the parking enforcement employee first started there were some employees downtown that was parking down there and it was affecting the parking on Matthews that the church uses for their day school, for parents to come and go. It was beginning to cause a problem, but for some reason they quit parking there. He was wondering if that could be included in the enforcement area.

City Attorney Carol Duncan noted the ordinance states specific street parameters. She quoted Section 66-228. It specifies all on street public parking bounded by Matthews Avenue, north to Cate, Burke Street and Union, east to Church Street. Councilman Vance stated then they're covered. City Attorney Duncan answered yes.
