COM-13:001 Presentation by Mark Nichols, Traffic Engineer

Mr. Nichols presented the Council with information concerning the traffic coordination plan (see attached file). Councilman Dover asked how the timing schedules will be changed. Mr. Nichols explained they will use the TACTICS Central Software to tell the signals what timing plans to use. Councilman Moore asked if that can be done on highways that are controlled by the state without interaction with the state. Mr. Nichols answered yes, but they may require permits when the plans are changed. Councilman McCall then questioned if there is a rough estimate as to when the work will be done. Mr. Nichols stated the work will take about 1-1/2 to 2 years depending on how much time is dedicated to the plan. Councilman Fears thanked Mr. Nichols for the presentation because not everyone realizes the work that is involved with coordinating the signals. Councilman Moore questioned if they will be able to figure out the amount of money saved per car after improvements are made to roads, such as Stadium Boulevard. Mr. Nichols answered yes. Councilman McCall then asked if coordinating the signals will decrease the number of accidents. Mr. Nichols stated after they are able to receive some data, they will be able to tell whether or not accidents were reduced. Further discussion was held concerning traffic signals.

#### 8. MAYOR'S REPORTS

Mayor Perrin reported on the following items:

In the Public Works Committee meeting, they decided the City should do nothing concerning the paving of a street in the Harmon Industrial Park as requested by Mr. Don Latourette. City Attorney Phillip Crego explained a private developer cannot require the City make those types of improvements. He noted the City can make the improvements during regular business, but the City is not required to do so. Councilman Johnson motioned, seconded by Councilman Coleman, to uphold the decision of the Public Works Committee. All voted aye. Mayor Perrin stated he will send Attorney Skip Mooney a letter tomorrow concerning the decision.

The Highway Department visited last Friday. They toured the City and looked at several top priorities. They have received word the Highway Department is looking at a federal grant to help with the cost of an overpass on Highland Drive to go over the railroad tracks. He, along with Chief Operating Officer LM Duncan and Alderman John Street will be attending an upcoming Highway Department meeting and will discuss those priorities.

The signal at the new NEA Baptist Hospital is up. They will be asking the Highway Department to turn the signal on.
