PROJECT: City of Jonesboro Strawfloor Road Landfill LFG Collection and Control System Construction Project

You are notified that your Bid dated May 9, 2007 for the above Contract has been considered. You are the apparent Successful Bidder and have been awarded a contract for all Work as specified or indicated in the contract Documents. The Work generally includes the following:

*Installation of landfill gas collection and control system including extraction wells, collection piping, blower and flare, and condensate collection, transmission, and storage facilities.*

The Contract Price, which is the total Lump Sum Price as presented in the Bid Schedule (part of the Bid Form and attached to the Agreement), is **one million, eleven thousand, one hundred thirty-one dollars (\$1,011,131.00)**. Determinations of actual quantities and classifications for Unit Price Work, and adjustment of Unit Prices, will be made as necessary in conformance with the General Conditions and Supplementary Conditions.

Three copies of each of the Contract Documents accompany this Notice of Award.

You must comply with the following conditions precedent within fifteen calendar days of the date of this Notice of Award, that is by June 27, 2007.

NOTICE OF AWARD (Cont.)

1. You must deliver to the OWNER three fully executed counterparts of the Agreement including all the Contract Documents. This includes the triplicate sets of Drawings. Each of the Contract Documents must bear your signature on the cover page and where indicated on the documents.
2. You must deliver with the executed Agreement the Contract Security (Bonds) as specified in the Instructions to Bidders (paragraph 18), General Conditions (Article 5), and Supplementary Conditions.

Failure to comply with these conditions within the time specified will entitle OWNER to consider your Bid in default, to annul this Notice of Award and to declare your Bid Security forfeited.

Within ten calendar days after you comply with the above conditions, OWNER will return to you one fully signed counterpart of the Agreement with the Contract Documents attached.
