ORDER FOR ANNEXATION

On this \mathcal{L} day of November, 1971, comes on to be heard the petition of Fisher Moving & Storage Company, Inc., an Arkansas Corporation, M. E. Carter, Inc., an Arkansas Corporation, Earl C. Keich Gin and Elevator Company, Inc., an Arkansas Corporation, and the City of Jonesboro, Arkansas, a municipal Corporation, praying for the annexation of:

A 4 core square in the Northwest corner of the NW\$\frac{1}{1} NE\$\frac{1}{2}, 38 cores in the NE\$\frac{1}{2} NW\$\frac{1}{2} and 1.5 cores in the NW\$\frac{1}{2} NW\$\frac{1}{2} and 1.5 cores in the NW\$\frac{1}{2} NW\$\frac{1}{2} all in Section 26-Township 14 North-Range 4 East, being more particularly described as follows: Begin at the Southeast corner of Veon Kiech Addition to the City of Jonesboro, Arkansas; thence North to the North line of Section 26-Township 14 North-Range 4 East; thence East to the Northeast corner of said NE\$\frac{1}{2} NW\$\frac{1}{2}; thence East; thence East to the Northeast corner of said NE\$\frac{1}{2} NW\$\frac{1}{2}; thence South along said line to the Southeast corner of said NE\$\frac{1}{2} NW\$\frac{1}{2}\$ thence West to the Southwest corner of the NW\$\frac{1}{2} NW\$\frac{1}{2}\$ of said Section 25; thence North on the 40 core line to the North right of way line of the St. Louis and S.F. Railroad; thence East along said right of way line to the West line of the NE\$\frac{1}{2} NW\$\frac{1}{2}\$ of said Section 25; thence North along said line to the South line of Veon Kiech Addition; thence East to the Southeast corner of Veon Kiech Addition, the point of beginning, containing 43.5 cores, more or less.

to the City of Jonesboro, Craighead County Arkansas. From the evidence adduced, the Court finds the above described property is contiguous to and adjoins the city limits of Jonesboro, Arkansas. The petitioners constitute a majority of real estate owners of the above described lands as required by Section 19-301, Ark. Stats. Notice of the time, place and date of this hearing has been published ence a week for three consecutive weeks in the Jonesboro Evening Sun, a newspaper of general circulation in Craighead County, Arkansas, first publication thereof was thrity days before this hearing. The petition herein has been filed for not less than thrity days.

The Court further finds that the statements of the Petition are true, that the territory sought to be annexed has been accurately described, and accurate map of the lands has been made and filed, and that the lands described above should be annexed and no objections have been made to said annexation.

IT IS THEREFORE CONSIDERED, ORDERED AND ADJUDGED that the prayers of the petitioners, Fisher Moving & Storage Company, Inc., M. E. Carter, Inc., Earl C. Keich Sin and Elevator Company, Inc., and the City of Jenesbore, Arkansas, being right and proper, are hereby granted and that the above described lands are hereby annexed to and made a part of the city limits of Jenesbore, Craighead County, Arkansas.
