Mayor Perrin explained the amount for this 2011 model with 636 hours on it is \$145,000. He added this excavator has a longer span and will allow the City to remove more material from a project.

Councilman Darrel Dover asked if this is replacing a piece of equipment. Mayor Perrin answered it is adding a piece of equipment.

Councilman Chris Moore questioned if the excavator is from the Caterpillar dealer. Mayor Perrin answered it is from JA Riggs in Jonesboro. Councilman Moore then asked if a warranty was included. Street Superintendant Steve Tippitt answered it has a 2 year warranty.

Councilman Moore also asked how much a new excavator would cost. Mr. Tippitt answered a new one would cost \$230,000. Councilman Moore then inquired if this item is budgeted. Mayor Perrin answered yes.

Mr. Tippitt noted the City is getting this excavator to mow the City's ditches.

Councilman Mitch Johnson asked if this ordinance needs to be placed on tonight's Council agenda. Mayor Perrin answered if possible. Mr. Tippitt stated the City has 2 projects coming up that will require two machines. Councilman Moore questioned if this ordinance could wait for the next Council agenda. Mr. Tippitt answered the City can work around it.

*Mayor Perrin explained this resolution is with Burlington Northern and the City hadn't signed an agreement with the railroad company for any of the tracks inside the City limits with the exception of the tracks behind World Color. He added new tracks have been built since that contract was signed and so this is an amendment to that contract.*

*Mayor Perrin then asked if the contract is with Burlington Northern and Union Pacific or just Burlington Northern. City Engineer Craig Light answered it is with just Burlington North. Mr. Light added the City has an agreement for the first phase of track, but two additional phases have been added and this contract will include those phases. He noted the terms of the agreement will not change.*

*Mayor Perrin stated City Attorney Phillip Crego has been working with Burlington Northern's legal team concerning this matter.*
