

DESCRIPTION OF PROPOSED STREET:

A PART OF THE NE $\frac{1}{4}$  SE $\frac{1}{4}$  OF SECTION 5-TOWNSHIP 13 NORTH-RANGE 4 EAST, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:  
 BEGIN AT THE NORTHEAST CORNER OF THE NE $\frac{1}{4}$  SE $\frac{1}{4}$  OF SECTION 5-TOWNSHIP 13 NORTH-RANGE 4 EAST; THENCE S1° 52' W ON THE SECTION LINE 711.97 TO THE POINT OF BEGINNING PROPER; THENCE N89° 43' W 457.0' TO THE P.C. OF A D=220° 05' CURVE TO THE LEFT; THENCE SOUTHWESTERLY ON SAID CURVE 109.0' TO THE P.C. OF A D=27° 29' CURVE TO THE RIGHT; THENCE SOUTHWESTERLY ON SAID CURVE 88.0' TO THE P.T. OF SAID CURVE; THENCE N89° 43' W 311.4' TO THE P.C. OF A D=114° 35' CURVE TO THE LEFT; THENCE NORTHWESTERLY SOUTHWESTERLY AND NORTHEASTERLY ON SAID CURVE 201.8'; THENCE S89° 43' E 311.4' TO THE P.C. OF A D=220° 05' CURVE TO THE LEFT; THENCE NORTHEASTERLY ON SAID CURVE 109.0' TO THE P.C. OF A D=27° 21' CURVE TO THE RIGHT; THENCE NORTHEASTERLY ON SAID CURVE 88.0'; THENCE S89° 43' E 455.6' TO THE EAST LINE OF AFORESAID NE $\frac{1}{4}$  SE $\frac{1}{4}$ ; THENCE N1° 52' E ON THE SECTION LINE 50' TO THE POINT OF BEGINNING PROPER.

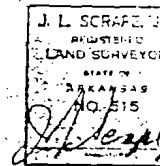

TRACT B: Begin at the Northeast corner NE $\frac{1}{4}$  SE $\frac{1}{4}$  of Section 5-Township 13 North-Range 4 East; thence S1° 52' W on the Section line 761.9'; thence N89° 43' W 20' to the point of beginning proper; thence N89° 43' W 217.8'; thence S1° 52' W 200'; thence S89° 43' E 217.8'; thence N1° 52' E 200' to the point of beginning proper, containing one acre, more or less.
