

A PETITION EXPRESSING CONCERN AND OBJECTIONS TO A REQUEST FOR THE RE-ZONING OF A PIECE OF PROPERTY CONSISTING OF APPROXIMATELY 3.06 ACRES ON THE SOUTHWEST CORNER AT THE INTERSECTION OF SCOTT STREET AND BELT STREET FROM ALREADY ZONE R-1 (single-family residential) TO LESS RESTRICTIVE ZONE R-2 (multi-family dwellings such as apartments and duplexes)

• Placed on first reading a proposal to rezone 3.06 acres on the southwest corner of the intersection of Scott and Belt from R-1 (single-family residential) to R-3 (multi-family residential).

Al Blanks said the Northside Church of Christ wants to expand and hopes to sell the property to another church. If not sold as a church, he said, the property will be "more marketable" zoned R-3.

Several property owners in the area objected to the proposal, citing traffic on Scott and the concentration of apartment units in the area northwest of the Arkansas State University campus.

This is a written and signed petition expressing concern and objections to a request for re-zoning from R-1 (residential single family dwellings) to a different less restrictive zoning of R-2 (multi-family dwellings such as High Rise Apartments, Garden Type Apartments, Townhouses, and/or Duplexes), a piece of property of 3.06 acres on the Southwest Corner of the intersection of Scott Street and Belt Street within the City of Jonesboro, Arkansas.

This petition will be presented to the Alderman (City Council) for the City of Jonesboro and/or any other agent responsible for the proper, orderly and appropriate development of our City and for the well-being of its citizens residing therein.
