City Engineer Craig Light explained this is a settlement with a surety company for a subdivision that went into default and has been in default for a couple of years. He added the settlement will allow the City to finish the development.

Councilman Moore asked if the amount of money the City will receive is the amount it will take to fix the streets in the subdivision. Councilman Moore then asked if there be a match from the City. Mayor Perrin answered no.
