ORDER OF CONFIRMATION OF ANNEXATION

On this $\prod_{i=1}^{n}$ day of <u>february</u>, 1991, comes on for hearing before the Court the above-styled cause and matter now appearing for the approval and confirmation of the annexation of said lands heretofore dated January 11, 1991. The Petitioners appear by and through their attorneys, Lyons & Emerson. The matters upon pleadings and orders with exhibits thereto filed herein, the certificate of the County Court Clerk of Craighead County, Arkansas, certifying that no proceedings have been filed in the Circuit Court of the Western District of Craighead County, Arkansas, to prevent the annexation of said lands and territories herein, from all of which together with other things and matters before the Court, the Court doth find:

1. That said lands herein have been annexed to the City of Jonesboro by Order of this Court dated January 11, 1991, and that no proceedings have been filed in the Circuit Court of the Western District of Craighead County, Arkansas, to prevent such annexation within thirty (30) days from the date of said order and annexation, and that said annexation was in all things done in conformity with the laws and statutes of the State of Arkansas, and should therefore be approved and confirmed; that said territory should be accepted by the City of Jonesboro; that the lands and territories annexed to the City of Jonesboro, Arkansas, are described as follows, to wit:

Beginning at the Southeast corner of the Southeast Quarter of the Northeast Quarter of Section Eight (8), Township Fourteen (14) North, Range Three (3) East, running West 2 rods for a point of beginning, thence North 260 feet, thence West 160 feet, thence South 260 feet, thence East 160 feet to the point of beginning.

IT IS, THEREFORE, BY THE COURT, CONSIDERED, ORDERED and ADJUDGED that the annexation of said lands and territory herein to the City of Jonesboro, Arkansas, be and in all things approved and confirmed, and that the proceedings before this Court be and are hereby confirmed. The Clerk of this Court be and is hereby authorized and directed to certify one (1) copy of the plat of such annexed territory with one (1) copy of this order of this County Court and resolution or ordinance of the City of Jonesboro, Arkansas, and forward a copy of each to the Secretary of State who shall file and preserve the same and shall forward one (1) copy of the plat of said annexed territory and one (1) copy of this order to the Director of Tax Division of the Arkansas Public Service Commission who shall file and preserve the same and shall notify all utility companies having property

in said municipality of this annexation of property, and the Clerk is directed to forward a certified copy of this order to the City Clerk's office of the City of Jonesboro,
