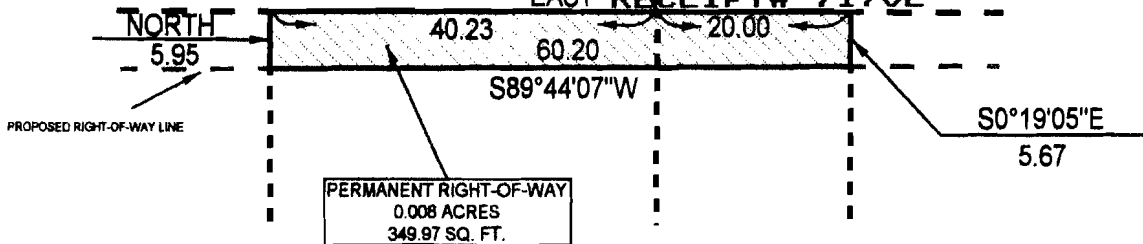

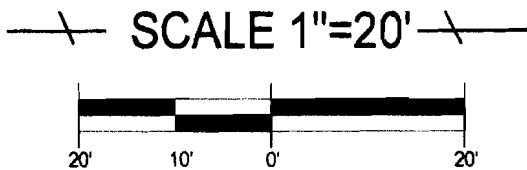
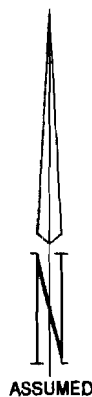


PLAT OF SURVEY
