

## CONTRACT

**THIS AGREEMENT** made this 2nd day of January, 2007, by and between Cameron Construction Company, Inc. ) a Corporation organized and existing under the laws of the State of Arkansas hereinafter called the "Contractor" and the City of Jonesboro, Arkansas hereinafter called the "Owner".

### WITNESSETH:

That the Contractor and the Owner for the consideration stated herein mutually agree as follows:

**ARTICLE 1. Statement of Work.** The Contractor shall furnish all supervision, technical personnel, labor, materials, machinery, tools, equipment, incidentals and services, including utility and transportation services and perform and complete all work required for the labor and equipment needed to perform stripping of approximately 61,000 square yards of topsoil at the Allberto factory location, in strict accordance with the Contract Documents,.

**ARTICLE 2. The Contract Price.** The Owner will pay the Contractor, because of his performance of the Contract, for the total quantities of work performed at the lump sum price of \$39, 750.00 based upon the unit prices stipulated in the Proposal, subject to additions and deductions as provided in the form of a properly executed Written Change Order.

**ARTICLE 3. Contract Time.** The Contractor agrees to begin work within one (1) day of receiving a "Notice to Proceed" and to complete the work within the time specified in the proposal thereafter.

**ARTICLE 4. Contract.** The executed Contract Documents shall consist of the following:

- a. This Agreement (Contract)
- b. Request for Price/Estimate in Writing (Proposal)

This Contract, together with other Documents enumerated in this Article 4, which said other Documents are as fully a part of the Contract as if hereto attached or herein repeated, form the Contract between the parties hereto. In the event that any provisions in any component part of this Contract conflicts with any provision of any other component part, the conflict shall be resolved by the Street Superintendent for the City of Jonesboro whose decision shall be final.

**IN WITNESS WHEREOF**, the parties hereto have caused this CONTRACT to be executed in one (1) counterpart, which shall be considered an original on the day and year first above written.

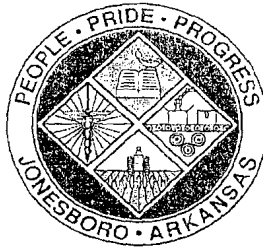

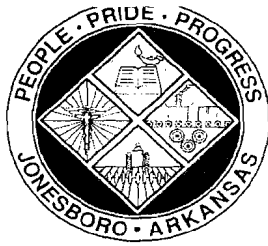

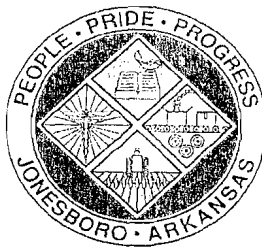
