Ordinances To Be Introduced

ORD-07:3166

AN ORDINANCE TO ESTABLISH COMPENSATION FOR ELECTED OFFICIALS OF THE CITY OF JONESBORO

Sponsors: Human Resources

Chairman Dover questioned whether a procedure had been set as to how the elected officials' salaries would be set each year. Councilman Perrin noted the ordinance is not that specific. He explained elected officials are not part of the City's salary plan, so most City's have an ordinance setting the salary. Human Resources Director Gloria Roark stated some City's put an amount for increases in the ordinance and other's just discuss it during the budget process. Councilman Perrin noted it would be HR's responsibility to go back and make a procedure to handle the salaries. City Attorney Phillip Crego stated in his opinion elected officials' salaries are already set by the budget ordinance. He also questioned if the City is not going to give increases on the same basis as other City employees then how the elected officials increases would be handled. Chairman Dover questioned whether the ordinance can be generic or whether it should state a policy. Mr. Crego answered the ordinance can be generic but a policy does need to be set. Councilman Perrin reiterated elected officials are not part of the salary plan so an ordinance needs to be passed to cover elected officials salaries. He added elected officials need to be compared and looked at on an annual basis. Mr. Crego asked for a policy or procedure to be set so outside factors may not interfere with the salaries of elected officials. Chairman Dover asked HR to come up with the procedure as to how salaries will be set for elected officials. Ms. Roark stated she thinks the elected officials salary increases should be handled each year during the budget process.

A motion was made by Councilperson Harold Perrin, seconded by Councilperson John Street, that this matter be Recommended to Council . The motion PASSED by an unanimous vote
