
Dear Mayor Perrin:

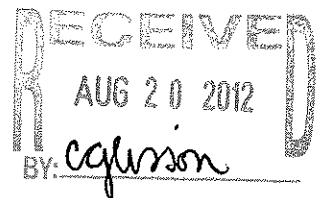
I thank you personally for your trust in me in appointing me to both of these commissions and I hope I have lived up to your trust.
